Beyond These Walls: Community Engagement Fund

Again, truly I tell you that if two of you on earth agree about anything they ask for, it will be done for them by my Father in heaven. For where two or three gather in my name, there am I with them.

Rationale:

UCC Norwell is a vital part of the South Shore and a dynamic community of faith. In order to foster our spirit of vitality and mission of creating ministers to the world, we are endeavoring to understand the community we live in, and to effectively engage it. There are many people in our region who care about faith and church, but a variety of activities compete for their time and attention. By reaching out, new people may find their way into our community, and our community's vitality will endure and be enhanced. Our goal is to develop the capacity to take our ministries out into the South Shore community that we serve.

UCC Norwell has created the Community Engagement Fund, a financial resource to help us reach out to our neighbors on the South Shore and build new relationships outside our church. We have a rich history of engaging in significant ministries that powerfully connect with the outside world. It is our intention that as we reach out, new people will find their way in to our community, and that they might become impassioned, as we are, to engage in ministry throughout the South Shore and the world.

Grant Criteria:

Church members can request funds for any ministry they want to bring out into our community that is aligned with the mission and values of members. There must be a direct connection to at least two members of UCC Norwell, and two or more people from our South. Shore community must be committed to the ministry in order for funds to be released. Proposals must demonstrate clearly how the proposed project will connect people outside UCC Norwell on the South Shore to the new ministerial initiative. These criteria should be applied to grant requests. In return, they will be reviewed with a generous spirit and a degree of flexibility.

- Initiatives must align with UCC Norwell's mission and values.
- A team of at least 2 UCC members must be part of the ministry initiative.
- Ministries must actively and directly engage people on the South Shore who do not currently participate in our church ministries.

The Community Engagement Fund will not consider:


- Capital campaigns
- For-profit organizations
- Research
- Governmental agencies
- Loans
- Political parties

Our interior life as a congregation:

Ministry and mission. We value being a congregation in mission in which every member connects the gospel message to their life to be an extension of Christ's ministry, and shares the Good News of God's reconciling love.

Education for ministry. As children, youth and adults we search, reflect, question, and journey together toward understanding our relationship to God and what faith means in all parts of our lives, empowering us for our ministries in home, school, work, community, nation, and world.

Risk-taking. We are willing to take risks to explore new opportunities for ministry and to set aside ministries when we no longer sense God's leading.

Stewardship of our resources:

Ministry teams. We value working in "ministry teams" of two or more persons, supporting and empowering each other, as we address the needs of the congregation and the wider world.

Organizational structure. We value an organizational structure that empowers our mission and ministries and is flexible to meet new challenges.

Church building. We value using our building for service to the wider community and see this as part of our ministry.

Giving. We believe in giving generously of our time, talent and treasure, seeking to be faithful stewards of all our resources.

Evaluation and Review Criteria for CEF Grants

Community Engagement Fund (CEF) proposals will be reviewed with a generous spirit and a degree of flexibility. The following criteria were adopted from the Capital Campaign document and will be used to evaluate proposals:

- The request for funds must be made by at least two church members regarding a ministry initiative to bring to the community.
- The ministry must align with the mission and core values of UCC Norwell.
- The ministry must actively and directly engage at least two people from our South Shore community who do not currently participate in our church ministries.
- It must be demonstrated how the ministry will connect people on the South Shore outside UCC Norwell to the new ministerial initiative.

Background considerations: The Committee will...

- encourage funding projects by existing ministry teams.
- consider whether there will be ongoing involvement of church members in the project.
- ask if this grant is more appropriately made by Mission & Outreach or other funding mechanisms.
- determine what methods of accountability exist and how these methods will be applied to monitor expenses. e.g. pre— and post—project reporting by a church member who is part of the ministry team.
- determine how the success of each project will be measured: will UCC
 Norwell be enriched, and benefit the South Shore community?
- consider whether the funds expended may be recaptured if the project is not successful or sustainable.
- or may seek complementary funding by outside groups or sources.
- ask if this can be a learning process for the a CEF ministry team and / or for the whole Congregation?

This is a fund with limited resources. Once the funds are expended, we cannot be a source for ongoing requests. Think of this as a Kickstarter program for church. This puts a premium on creative thinking for future funding.

We may suggest refinements to the project or request a pause to accomplish the desired objectives.
